### 1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing (RRS*). - 1.2 The 'Rules for Championships Sailing, Windsurfing and Kiteboarding' (available at <a href="reglement-voor-kampioenschappen-20191101-v5-docx.pdf">reglement-voor-kampioenschappen-20191101-v5-docx.pdf</a> (watersportverbond.nl) will apply for the Efsix and Spanker class.
- 1.3 The Sailing Instructions may change some RRS-rules. The changes will appear in full in the sailing instructions. The sailing instructions may change other rules as well
- 1.4 If there is a conflict between languages the text in the English language will take precedence.
- 1.5 Every person on board who has his domicile in the Netherlands shall have the appropriate license.

## 2 SAILING INSTRUCTIONS

#### 3 COMMUNICATION

- 3.1 Notices to competitors will be posted on the official notice board located near the regatta office
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## 4 ELIGIBILITY AND ENTRY

- 4.1 The events are open to all boats of the Spanker, Efsix and Javelin classes.

- 4.3 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.4 Late entries will not be accepted.

#### 15 SCORING

- 15.1 Four races are required to be completed to constitute a series.
- 15.2 (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
  - (b) When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 15.3 RRS 90.3(e) applies.

## 18 [DP] BERTHING

18.1 Boats shall be kept in their assigned places in the boat park or Harbour

#### 19 [DP] HAUL-OUT RESTRICTIONS

19.1 Efsix boats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

#### 20 [DP] DIVING EQUIPMENT AND PLASTIC POOLS

20.1 For the Efsix class, underwater breathing apparatus and plastic pools or their equivalent shall not be used around keel boats between the preparatory signal of the first race and the end of the event.

#### 21 DATA PROTECTION

21.1 By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

#### 22 RISK STATEMENT

- 22.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
- 22.2 The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### 23 INSURANCE

23.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 or the equivalent per incident.

#### 24 PRIZES









24.1 The RNWA supplies for winning boat or team a blue pennant and a medal for every member of the crew of the first three boats or crews of the Spanker and Efsix class (there will be no extra medals available for changes in the crew during the event).

The Javelin class organization supplies prizes for the Javelin class.

Additional prizes may be given, depending on the number of participants.










## Addendum A: the map of the location of the race office harbour.
